I understand that Charity will be the sole owner of the Content with the exclusive right, including copyright, to use and license to others, all or any portion of the Content. I agree that Charity is under no obligation to use, exhibit, or distribute the Content.

I understand and agree that I may be requested to provide certain information, written materials, biographical information, photographs, videos, or other materials (together, “Materials”). I hereby assign to Charity all worldwide right, title and interest in and to any such Materials, including all rights arising under applicable copyright laws, and I understand and agree that such Materials may not be returned to me at any time. I further understand and agree that Charity may incorporate any such Materials into the Content, and may further publish, broadcast, transmit, reproduce and otherwise publicly display any such Materials in or on one or more works created with the Materials or Content. I represent and warrant that any Materials I provide to Charity will be true, original, accurate and complete and will not violate the right of privacy or publicity of, or constitute a defamation against, any person or entity; that the Materials will not infringe upon or violate the copyright or common law rights or any other rights of any person or entity; and that there are no restrictions whatsoever upon the Materials.

I waive any right that I may have to prior inspection of the Content. I further waive any and all rights of privacy, publicity, or any other rights of a similar nature in connection with the Content, or any portion thereof, including without limitation my name and likeness, or any advertising or publicity relating thereto. I expressly release, defend, and forever hold harmless Charity from any and all claims, compensation, demands, liabilities, or causes of action, whether known or unknown, including reasonable attorney’s fees, for defamation, copyright infringement, violation of moral right, and invasion of the rights to privacy, publicity, or personality or any similar matter, in connection with my Appearance; the use of any Materials; and in any Content.

I agree to not issue any press releases or other public statements or speak to the press about the use of my Appearance or Materials in any Content without Charity’s prior written consent.

This Appearance Release (“Release”) shall be construed under the laws of the State of Florida without reference to its conflict of law principles. Exclusive jurisdiction of all disputes hereunder shall lie in the state and federal courts located in Duval County, Florida.
